

## Sen. Casey's Key Votes for Children

- voted against <u>H.R.1628</u>, the American Health Care Act, which
  would have repealed Medicaid expansion under the Affordable
  Care Act, repealed the individual and employer health care
  mandates, and otherwise modified the private health insurance
  market. This bill, which ultimately failed, would have led to 23
  million more Americans without health insurance by 2026.
- voted against H.R.1, the Tax Cuts and Jobs Act, which provided for tax cuts that disporportionately favor wealthy individuals and corporations. The bill is projected to add \$1.5 trillion to the national debt over ten years, which could lead to future cuts to important social safety net programs. The bill also repeals the individual health insurance mandate established under the Affordable Care Act, jeopardizing health insurance coverage for millions of people.
- voted for H.R.1892, the Bipartisan Budget Act, which extended CHIP for four additional years, funded a home visiting program for new mothers, funded community health centers, and modified funding and eligibility requirements for foster care prevention services.
- voted against H.R.1370, the Further Additional Continuing Appropriations Act, which extended funding for the government by four weeks and retroactively funded CHIP for the first half of fiscal year 2018.
- voted against the <u>confirmation of Betsy Devos</u> as Secretary of Education, which CDF opposed due to concerns about Devos's experience and her demonstrated opposition to robust enforcement of the Individuals with Disabilities Education Act and Title IX.
- voted against the <u>confirmation of Jeff Sessions</u> as Attorney General, which CDF opposed due to concerns about Sessions's poor record on civil rights and criminal justice.
- voted against <u>H.J.RES.57</u>, the resolution that nullified a
   Department of Education rule providing for federal standards
   for states implementing plans to meet the needs of historically
   marginalized groups under the Elementary and Secondary
   Education Act of 1965.

# Sen. Casey's Actions in CDF's Core Policy Areas

#### Casey on Health Care

- voted against H.R.1370, the Further Additional Continuing Appropriations Act, which extended funding for the government by four weeks and retroactively funded CHIP for the first half of fiscal year 2018.
- voted against <u>H.R.1628</u>, the American Health Care Act, which would have repealed Medicaid expansion
  under the Affordable Care Act, repealed the individual and employer health care mandates, and otherwise
  modified the private health insurance market.
- voted for H.R.1892, the Bipartisan Budget Act, which extended CHIP for four additional years, funded a
  home visiting program for new mothers, funded community health centers, and modified funding and
  eligibilty requirements for foster care prevention services.
- co-sponsored S.1112, the Maternal Health Accountability Act, which would support states in improving outcomes for mothers during pregnancy.
- **co-sponsored S.1462**, the Marketplace Certainty Act, which would amend the Affordable Care Act to gradually reduce subsidy payments to insurance companies.
- co-sponsored S.1827, the KIDS Act, which would extend CHIP funding for five years.
- co-sponsored S.2001, the State Public Option Act, which would establish a public health care option through Medicaid.

### Casey on Fighting Poverty

- **voted against <u>H.CON.RES.71</u>**, the 2018 congressional budget resolution, which established the budget for fiscal year 2018. This resolution included reconciliation instructions which allowed for the eventual passage of H.R. 1, the Tax Cuts and Jobs Act, with a simple majority in the Senate.
- voted against <u>H.R.1</u>, the Tax Cuts and Jobs Act, which provided for tax cuts that disporportionately favor
  wealthy individuals and corporations. The bill is projected to add \$1.5 trillion to the national debt over ten
  years, which could lead to future cuts to important social safety net programs. The bill also repeals the
  individual health insurance mandate established under the Affordable Care Act, jeopardizing health
  insurance coverage for millions of people.
- sponsored S.470, the Child and Dependent Care Tax Credit Enhancement Act, which would raise the
  income level at which the Child and Dependent Care Tax Credit phases out, increase the value of the
  credit, index the credit to inflation, and make the credit fully refundable.
- **co-sponsored S.1371**, the Working Families Tax Relief Act, which would increase the amount of the child tax credit and the portion of the credit that is refundable.
- **sponsored S.1630**, the Child Poverty Reduction Act, which would establish the Federal Interagency Working Group on Reducing Child Poverty to develop a national strategy to eliminate child poverty.

#### Casey on Child Welfare

- **co-sponsored S.439**, the Timely Mental Health for Foster Youth Act, which would require mental health screenings within 30 days after a child enters foster care.
- **sponsored S.885**, the Improved Employment Outcomes for Foster Youth Act, which would expand the Work Opportunity Tax Credit (WOTC) to include the hiring of qualified foster care transition youth.
- **sponsored S.937**, the Adoption Tax Credit Refundability Act, which would make the tax credit for adoption expenses refundable.
- **co-sponsored S.1091**, the Supporting Grandparents Raising Grandchildren Act, which would establish a federal task force to support grandparents raising grandchildren.
- **co-sponsored S.1357**, the Family-Based Care Services Act, which would provide funding for therapeutic family care services in Medicaid. Such programs provide parents, caregivers, or foster families with training necessary to care for children with mental illness, emotional or behavioral disorders, or other conditions.

- **sponsored S.1797**, the Health Insurance for Former Foster Youth Act, which would ensure health care continuity for children aging out of the foster care system.
- **sponsored S.2696**, the Supporting Infant Plans of Safe Care Implementation Act, which would provide for grants to states to support the health and safety of infants born with drug dependency.

#### Casey on PreK-12 Education

- **voted against <u>H.J.RES.57</u>**, the resolution that nullified a Department of Education rule providing for federal standards for states implementing plans to meet the needs of historically marginalized groups under the Elementary and Secondary Education Act of 1965.
- voted against the <u>confirmation of Betsy Devos</u> as Secretary of Education, which CDF opposed due to concerns about Devos's experience and her demonstrated opposition to robust enforcement of the Individuals with Disabilities Education Act and Title IX.
- **co-sponsored S.1674**, the School Building Improvement Act, which would provide grants for the repair, renovation, and construction of public elementary schools and secondary schools.
- co-sponsored S.2542, the IDEA Full Funding Act, which would fully fund part B of the Individuals with Disabilities Education Act.
- sponsored \$.2572, the Safe Schools Improvement Act, which would require local educational agencties to
  establish anti-bullying policies and prohibit bullying based on race, color, national origin, sexual orientation,
  gender identity, or religion.
- **co-sponsored S.2584**, the Student Non-Discrimination Act, which would prohibit discrimination based on sexual orientation or gender identity of a student or a person associated with that student in any educational program or activity receiving Federal financial assistance.

#### Casey on Juvenile Justice

- **voted against** the **confirmation of Jeff Sessions** as Attorney General, which CDF opposed due to concerns about Sessions's poor record on civil rights and criminal justice.
- co-sponsored S.329, the MERCY Act, which would restrict the use of solitary confinement for juveniles in federal custody.
- **sponsored S.866**, the Prohibiting Detention of Youth Status Offenders Act, which would eliminate the use of valid court orders to secure lockup of status offenders.
- co-sponsored S.1917, the National Criminal Justice Commission Act, which would reform sentencing laws
  and corrections and include provisions on parole for juveniles, sealing of juvenile records, and juvenile
  solitary confinement.

#### Casey on Gun Reform

- co-sponsored S.2009, the Background Check Expansion Act, which would require background checks for every firearm sale.
- **co-sponsored S.2095**, the Assault Weapons Ban, which would criminalize the sale, manufacture, transfer, or possession of a semiautomatic assault weapon or large capacity ammunition feeding device.

#### **Casey on Nutrition**

- co-sponsored S.1064, the Anti-Lunch Shaming Act, which would prohibit public identification or stigmatization of children who lack funds to pay for a meal or have outstanding credit.
- **co-sponsored S.1724**, the Healthy Food Access for All Americans Act, which would establish a new tax credit and grant program to stimulate investment and nutrition options in food deserts.

#### Casey on Early Childhood

• **co-sponsored S.1690**, the CCAMPIS Reauthorization Act, which would reauthorize a program that provides campus-based child care for parents in college.

• **co-sponsored S.1806**, the Child Care for Working Families Act, which would expand and improve the Child Care and Development Block Grant and provide grants for funding high-quality preschool.

# Casey on Housing

• **co-sponsored S.548**, the Affordable Housing Credit Improvement Act, which would increase state credit allocations and make several adjustments to the low-income housing tax credit.
